Dkt. 15. This 11 Stipulation was agreed upon to allow the Parties to engage in additional discussions, 12 as well as to allow Defendants sufficient time to consider and discuss important 13 decisions concerning this litigation. 14 The Parties' Stipulation also agrees that, should Defendants file a Motion to 15 Dismiss pursuant to Rule 12(b) in response to the Complaint, the deadline for 16 Plaintiffs' opposition would be August 18, 2023. The deadline for Defendants' reply 17 to Plaintiffs' opposition would be September 8, 2023. The Stipulation does not 18 constitute a waiver of any claim, right, or defense. 19 The court, having considered the Parties' Stipulation and finding good cause 20 therefor, hereby GRANTS the Stipulation and ORDERS as follows: 21 1. Defendants' deadline to file a response to the Complaint is extended to 22 July 21, 2023; 23 2. Should Defendants file a Motion to Dismiss pursuant to Rule 12(b) in 24 response to the Complaint, Plaintiffs' opposition to Defendants' Motion 25 to Dismiss is due August 18, 2023; and 26 /// /// 27
